Property liens were discussed and properties will be reviewed yearly for potential lien placement

Scott Maurer stated they have quotes and jobs lined up and ready once the \$70,000.00 grant money is received. New turbidity meters were installed and a new stainless steel stem was made for the valve at the reservoir and will be installed in the spring.

The delinquent report was reviewed with \$21,030.94 in delinquents. Over 70 ten day notices were sent out. New meeting dates for 2021 were reviewed and Jack Schaeffer, Jr. made a motion to approve. Lee Moss 2nd the motion and all were in favor. A motion was made by Mark Challenger, Jr. to advertise for the (1) seat opening on the Authority for 2021. Jack Schaeffer 2nd the motion and all were in favor.

Jack Schaeffer, Jr. made a motion to pay the bills, Mark Challenger 2nd and all were in favor. Lee Moss made a motion to adjourn the meeting. Jack Schaeffer, Jr. 2nd the motion and all were in favor.
